### **NOTICE TO UNITHOLDERS ON FOREX RATE**

Singapore, 21 March 2012 – Hutchison Port Holdings Management Pte. Limited, the Trustee-Manager of Hutchison Port Holdings Trust (“HPH Trust”), would like to inform all unitholders of HPH Trust that the distribution of 23.40 Hong Kong cents per unit for the period from 1 July 2011 to 31 December 2011 will be paid on Thursday, 29 March 2012.

Unitholders who do not opt to receive their distribution in Hong Kong Dollars or US Dollars, will receive it in Singapore Dollars. The distribution to be paid in Singapore Dollars or US Dollars will be at the exchange rates of HK\$1.00 = S\$0.16256 or HK\$1.00 = US\$0.12879 being the buy rates of the corresponding currencies on 21 March 2012. This means that unitholders will receive S\$38.04 or US\$30.14 for every 1,000 units of HPH Trust held at the time of books closure.
