NOTICE TO UNITHOLDERS ON FOREX RATE

Singapore, 15 March 2013 – Hutchison Port Holdings Management Pte. Limited, the Trustee-Manager of Hutchison Port Holdings Trust (“HPH Trust”), would like to inform all unitholders of HPH Trust that the distribution of 27.19 Hong Kong cents per unit for the period from 1 July 2012 to 31 December 2012 will be paid on Tuesday, 26 March 2013.

Unitholders who have not opted to receive their distribution in Hong Kong Dollars or US Dollars, will receive it in Singapore Dollars. The distribution to be paid in Singapore Dollars or US Dollars will be at the exchange rates of HK\$1.00 = S\$0.16084 or HK\$1.00 = US\$0.12890 being the buy rates of the corresponding currencies on 15 March 2013. This means that unitholders will receive S\$43.73 or US\$35.05 for every 1,000 units of HPH Trust held at the time of books closure.
